Publication of the Newton Neighbourhood Plan (Pre-Submission Version) The Neighbourhood Planning (General) Regulations 2012 (Regulation 14)

Newton Parish Council, as the qualifying body, and supported by the Neighbourhood Plan Steering Group, has prepared a Neighbourhood Plan for the period to 2036 (the Plan) for Newton Parish. The Plan sets out a vision for the future of the parish and planning policies which will be used to determine planning proposals locally.

Newton Parish Council is now inviting comments on the proposals in this Pre-Submission version of the Plan before it is submitted to Babergh District Council for formal consideration and wider consultation.
