### Guidance for golf on the green at Newton

Upon registering annually with the club and booking in at the professional's shop before play, residents of the village can enjoy nine holes free golf on the village green. All guests must pay a green fee. An extra nine holes on the private side of the course can be played after paying the appropriate fee at the club shop.

### Villager-Plus Membership

To enjoy regular, 18-hole golf, residents can take out Villager-Plus membership of the club, which involves paying half the normal full, seven-day fee (£377.50 in 2017-18). Subject to the guidance of the professional's shop, play will be available daily from 10.30 am, and 12.30 pm on Saturdays. A condition of Villager Plus membership involves a free, one-hour, introductory session with the club professional.

## TONY MARSHALL

It is with sadness that I report the death of Tony Marshall at the age of 83. Anthony William James Marshall was the third child of Elsie and Bill Marshall who lived at Excelsior in Newton. Tony's eldest sister Faith was sadly drowned at Clacton in 1945 at the age of 18 years. The middle sibling Joyce lived into her eighties and had been at school teacher. Tony was at school at St. Josephs College in Ipswich where he became Captain of the 1st. eleven cricket team. From school there came National Service 1953-55 with the Royal Medical Corp. On leaving the army he attended Writtle Agricultural College at Chelmsford. Tony inherited Home Farm, Assington from his grandfather in the 1950's. Home Farm was where what is locally known as the Round House, No. 72 Further Street. However, Tony continued to live in Newton with his parents until he and Jill Mitcham decided to get married, meanwhile his grandmother continued to live at Home Farm until her death in the early 1960's. The house was then lived in by Reg Marshall who was a cousin along with his friend Bob Clackson until the house was needed by Tony when he and Jill wanted to begin their married life there. The friends then moved to 81 Dyers Lane at Christmas 1962. The property was then 'modernised', Tony had the electricity connected ready for married life with Jill. The wedding took place at Assington Church in March 1963 with the reception at the old village hall that used to stand opposite the Village school. Their son Richard arrived in 1969.

During his life Tony was a keen golfer playing off single figures and when Arthur Davey, the club professional was not able to maintain the greens and fairways any longer Tony and Bobby Ablitt took over driving an old "fergi" which dragged a gang of cylinder mowers behind. Tony was always a keen club member and he was a member of the Hambro team which won the cup in 1972. Tony became Club Captain in 1975.

Shooting had always been a favourite occupation of Tony and he was a very good shot despite having had a bad experience as a boy of 9 years when a poacher in the wood behind Home Farm shot at him, whether on purpose or by accident was never very clear, leaving shot in his leg until the day he died. He was also ready to help out at Christmas time plucking chickens and turkeys being faster and better than anyone else.

Always a keen Ipswich Town football supporter Tony held a season ticket throughout the 60's and 70's. Later when George Burley was manager Tony would ring Radio Suffolk and join their quiz answering questions on football and often winning complimentary tickets to watch the game at Portman Road. In the early 80's Tony built a new house adjacent to Home Farm on the site of a derelict cottage. The works carried out by Tony himself, his father and builder from Bower Tye named Bond. The old saying "a man should build a house, have a son and plant a tree during his life" was certainly true of Tony. In the 90's his marriage to Jill was dissolved and he then married Estelle Wilson who was a very keen dog breeder. On March 20th 2019 Tony was taken to the West Suffolk hospital where he remained until his death on 4th. March 2019. Tony is survived by his wife Estelle, Jill and their son Richard.

**60 YEARS AGO – Newton Newsleaf produced by Rev A G Ensor**

**JUNE 1959:**

**Dear Friends:** The CHURCH FETE is on Saturday June 20<sup>th</sup> in Mrs Warner's garden (Broomfield). Whatever the weather I do hope you will all come along and help to make the Fete a great success. In the past 3 years the amounts raised have been exceptionally good so perhaps we shall be able to reach and pass the £100 mark.

We are grateful to Miss Stella Smith who is to open the Fete this year. In view of her long connection with this parish it would be difficult to find a more suitable person.

I was sorry not to have been present at the Jumble Sale in April. The sum raised was excellent - £26. 15.8. Thank you to all who gave and all who helped.

On May 20<sup>th</sup> the marriage took place between Miss Marjorie Wade and Mr Brian Wright. We wish them every happiness in their new home.

Harriet Mabel Warren died on May 31<sup>st</sup>. She and those who nursed her were an inspiring example of Christian fortitude and cheerfulness to all who visited her during her long illness.

The decision of the West Suffolk education authorities not to close ASSINGTON school after all is a good one and Newton parents and children will join in welcoming the new Headmistress. Congratulations to Susan Watson and Beryl Humm on passing the 11+ examination. May they be happy and make good progress at their new schools. A.G.Ensor

**40 YEARS AGO - Newton Newsletter edited by Frank Rowland**

**MAY 1979:**

**Village Hall Notes:** The AGM was held on 23<sup>rd</sup> April when an almost record crowd of parishioners attended, in addition to 7 committee members. The Chairman, Mr John Beevis, reviewed the past year and reported a balance of £177.90 compared with the previous year of £324.05: the reduction was partly due to the cost of £300 for a new front door. Mr Beevis reported that it was proposed to seek planning permission for a car park on the ground to the south of the Hall, previously used as an allotment. This would obviate the need for cars to be parked on the green. A vote of thanks was accorded to Mr Rufus who took over from the late Mr Langley the work of auditing and preparing the accounts. ## **JUNE 1979:**

**Fireside Club:** I am sorry to have to record the deaths of two of our oldest members, Mrs Jamieson and Miss Copping. Although Agnes had moved to Sudbury, she had been a very faithful member. She will be remembered by many as 'Madame Malachi' with her fortune telling cards. Mrs Jamieson was able to come to our meeting on 11<sup>th</sup> May and enjoyed a game of whist. She leaves behind 4 daughters and one son, thirteen grandchildren and twenty one great grandchildren.

## **25 YEARS AGO – Newton Newsletter edited by Kathy Searles**

### **MAY 1994:**

**Farewell Newton:** In the September newsletter last year I ended my Editorial with saying farewell to the people of Newton until the July 1994 issue when I would once again take over the job as Editor for the summer months. Alas it was not to be! Ernestine and I were given an ideal opportunity to buy a flat in a retirement home in Petersfield, Hants, only about 10 miles from our elder daughter and family. When we first came to Newton we were seized upon at once for every job in sight. I became Lay Reader and Ernestine churchwarden. The Church in those days was in a very parlous state. The only seating was on very hard wooden chairs, there was no organ, only an ancient clapped out piano. Ernestine managed to sell the Babington organ, which was far too big for the Chancel area. It was bought by a Dutchman for £500 and is now in one of the most prestigious churches in the middle of Prague. I hope the two young people who are buying our house will enjoy Newton as much as we have. Gaspard Willis

### **JUNE 1994:**

**Parish Council:** At the Annual meeting held on 25<sup>th</sup> May, Mr John Taylor was re-elected Chairman, and Mr Harry Buckledee remained vice-chairman. The Bus shelter provision in Plampin Close was considered and prices were examined for cantilever shelters but it was felt these would be inappropriate in Plampin Close. Furteher investigation would take place. Mrs Molly Watson reported that the demonstration Boules evening had been poorly attended and no decision had been taken about the establishment of regular Boules games. Detailed planning permission was being sought for the detached houses in Church Road at the corner of Alston Close. Concern was expressed about the proposed houses overlooking gardens in Alston Close. Great Horkesley Parish Council had asked for support against a new access road to the A12 from the A134, but the Council felt this would be an advantage to Newton residents, and the increase in traffic could prove to be smaller than envisaged. 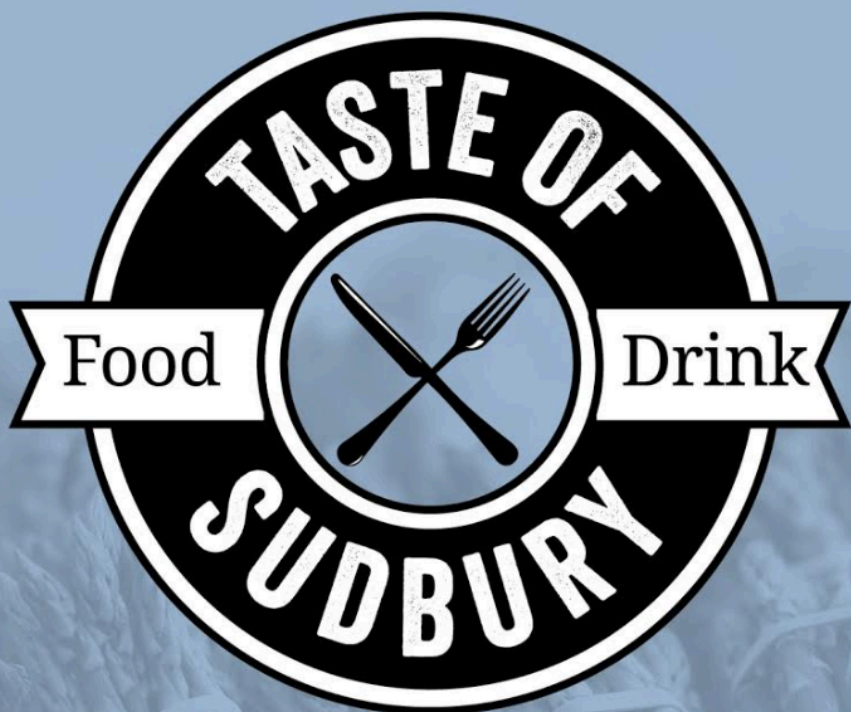

**19/051 Annual Subscriptions**

It was resolved to renew the annual membership to SALC, Community Action Suffolk and The Society for Local Council Clerks for 2015 / 2016.

**19/052 Public Forum**

- a. A member of the NNPT raised an objection regarding NPC's plans to apply for CIL money to fund the replacement of equipment to the play area, when their recent survey had indicated that there was no strong demand, and why was there no provision for adult fitness equipment? Cllr. Presland stated that the application needed to proceed because of the shortage of time. However, if the application was successful, there would be further consultations as to what equipment was given priority.
- b. A complaint was made regarding the flooding of Rectory Road, bought about by a new entrance for Abbey House. Cllr Taylor responded that this was being handled by Newton Green Trust. Their Insurers had been contacted, and there would be an update at the next meeting. Clerk also to contact Suffolk Highways Department to give them an update of the situation.
- c. There are on-going problems with Broadband in Newton. Please let the Clerk know your name and landline phone number; if you can receive superfast broadband but have not been connected.
