20/243 Apologies for Absence

Cllr Taylor (work commitments) sent his apologies.

## 20/244 Declaration of Interests and Requests for Dispensation

No interests were declared and no requests for dispensation had been received.

#### 20/245 Minutes of Meeting held on 9th September 2020

The minutes of the meeting were approved by the councillors who resolved that the minutes should be digitally signed by the Chairman as a correct record.

#### 20/246 Public Forum

Councillors reviewed James Finch's previously submitted report and he updated councillors on COVID-19 support for businesses and help line, SCC's decision not to support the Sizewell C planning application and charging point scheme for villages. Lee Parker updated councillors on Babergh's support payment for people self isolating due to COVID-19 if they meet criteria, Babergh's 6.74 year housing supply, Babergh's opposition to the Government's White Paper on Planning, Public Realm being brought in-house, the progress of the Sudbury Masterplan and the Bures appeal. Councillors agreed that the Clerk apply for Lee Parker's Locality Budget grant in support of the new bus shelter required by Links View.

Hannah Powell and Tristan Bourne updated councillors on the Perrywood planning application (Item 20/250a) and answered a number of questions on the proposals. The councillors thanked them for their attendance and hoped that Perrywood would be able to work with NPC on community initiatives in the future.

#### 20/247 Emails circulated

Following a review of the emails circulated by the Clerk since the last meeting, there were no further actions requested of the Clerk.

#### 20/248 Clerk's Report

Following a review of the Clerk's report (Appendix A), there were no further actions requested of the Clerk.

#### 20/249 Finance

- a. The councillors reviewed the External Audit report from PKF Littlejohn, which stated Section 1, Assertion 4 has been incorrectly completed. This was answered "Yes". however the Annual Internal Audit Report indicates that proper provision was not made during 2019 by answering "No" to Assertion L. The explanation provided indicates that the Public Rights notice was not published on the website, therefore Assertion 4 should have been answered "No". The councillors resolved to accept and approve the report..
- b. All cheques signed and due for signing, as itemised in the RFO Report (Appendix B), were authorised by the councillors. The councillors also noted the income received since the last meeting and reviewed the Statement of Accounts against the budget and the bank reconciliation against the bank statements.

- c. The councillors resolved to donate £100 towards the Royal British Legion's Poppy Appeal.
- d. Cllr Presland has sent the documentation for Cllr Bower and himself to be added to the authorised account signatories for NPC's bank accounts at Barclays. He has also requested that the correspondent for the bank accounts be changed from himself to the Clerk.

#### 20/250 Planning

- a. The councillors reviewed Planning Application DC/20/03810 Perrywood Garden Centre, Newton Road - Erection of a new garden centre building (Use Class A1) including restaurant, enclosed and open canopies and outdoor sales area. Erection of a glasshouse and store. Partial demolition of and erection of an extension to the existing garden centre building (to be used for Use Classes A1 and B1). Erection of a replacement potting shed. External alterations of the existing barn. Erection of electricity sub-stations and an electricity distribution building. Provision of landscaping, car parking areas, wildlife area and outdoor events space and resolved to support the application.
- b. The councillors reviewed Planning Application DC/20/03914 Marks Meadow, Rectory Road Application for approval of reserved matters following outline approval DC/20/00859 (Outline Planning Application (Access to be considered all other matters reserved) Erection of 3no. dwellings with garages and creation of new access) Phased development details for Landscaping, Design and Scale for Plot 1 only and resolved to support the application.
- c. The councillors reviewed Planning Application DC/20/03968 Valley Farm, Valley Road -Application for Listed Building Consent - Alteration to existing vehicular access and demolition of front wall, installation of hard surfaced driveways, patio areas and boundary treatments as detailed in the Design and Access Statement and accompanying plans and resolved to support the application.
- d. The councillors reviewed Planning Application DC/20/04179 Hills Barn, Sudbury Road -Erection of a single-storey detached cartlodge and resolved to support the application.
- The councillors reviewed Planning Application DC/20/04199 Buckledee Cottage, Assington Road - Erection of single storey rear conservatory extension and resolved to support the application.
- f. No further planning application had been received since the agenda was posted requiring a response before the next meeting.
- g. Hastoe updated NPC that they have now signed an agreement with Orwell regarding the development off Alston Close and now expects to purchase the land very shortly.
- The councillors reviewed the status of previous applications, appeals and enforcement referrals (Appendix C).

#### 20/251 Neighbourhood Plan

The Regulation 14 consultation on Newton's draft Neighbourhood Plan closed on the 12<sup>th</sup> October at 5pm with nine Statutory Stakeholder responses and 4 resident responses Two further responses had been received after the deadline but will be included in the consultation. NPC, the Steering Group and the consultant will now review the issues raised, develop a response to each and agree if the draft NP requires modification.

#### 20/252 Recreation Ground

Cllr Presland updated councillors on the installation of the MUGA which commenced on the 6<sup>th</sup> October and the planned pre-installation meeting with All Play Solutions regarding the Play Equipment and the Forever Fit Equipment on the 27<sup>th</sup> October which will agree the final positions of the equipment. Both Trust and NPC members will attend the meeting. The councillors were happy with the proposed positions of earth bunds outlined by Cllr Presland.

The councillors reviewed the proposed changes to the Risk Management Register for the inclusion of the assessment of risks related to GDPR, and resolved its adoption.

#### 20/256 Assets

The councillors resolved to ask the Trust to consider paying for a replacement commemorative oak tree marking the parish council service of John Taylor, which has died. Three residents have volunteered to undertake jobs on behalf of the parish. Carol Langley will undertake the repainting of the Village Sign, Tim Boyes will install a new road sign for the church and Doug Turner will remove the broken circular bench on the Green.

#### 20/257 Christmas Tree

Cllr Presland will contact the Christmas tree supplier and order a tree for installation around the 1<sup>st</sup> December 2020.

## 20/258 Village Hall and Trust updates

There has not been either a Trust or Village Hall meeting since the last NPC meeting. The Village Hall has agreed that NPC can engage an electrical contractor to review if a supply for the Recreation Ground can be installed from the Village Hall.

#### 20/259 Questions to the Chair

Cllr Smith asked that the charging point scheme be discussed at the November meeting, which was agreed. The replacement of the bus shelter at Links view will be discussed at the November meeting. Cllr Presland updated councillors that the golfing lessons being undertaken on the recreation ground, by a person not connected to the Golf Club, have now ceased.
